The College of Nursing Art and Science, University of Hyogo is currently recruiting for a full-time teacher. Please refer to the following guidelines when applying.

1. Number of positions:

1: Professor; Basic Clinical Nursing (Nursing Pathobiology, Basic Clinical Nursing)

2. Courses to be responsible

- (1) In addition to the above courses, the successful candidate will also be responsible for teaching various topic-based general education courses.
- (2) The courses to be responsible are subject to change after employment due to reorganization within the university.
- (3) The courses are included subjects in charge by two teachers.
- (4) In case of a doctor having medical license, Clinical Medicine (Surgery) is preferred.
- (5) We expect professors to open new areas of study in the doctoral program.

3. Eligibility requirements:

- (1) Doctoral degree (or equivalent education or research achievements)
- (2) Nursing license (to perform in a clinical setting in Japan under the Act on Public Health Nurses, Midwives, and Nurses) or Medical license
- (3) Experience in clinical nursing and education, and research activities
- (4) None of the following items shall apply:
  - ① Adult wards or persons under curatorship (including individuals deemed quasi-incompetent)
  - ② Persons sentenced to imprisonment or harsher penalties who have yet to complete their sentence or to whom such a sentence still applies.
  - ③ Persons who have received punitive or disciplinary dismissal from Public University Corporation of the University of Hyogo or Hyogo Prefecture within two years of the date of such punishment.
  - ④ Persons who, on or after the day of enforcement of the Constitution of Japan, have formed or become a member of a political party or any other organization which advocates the overthrow by force of the Constitution of Japan or the government existing under the Constitution.

4. The candidate will have:

- (1) Research achievements in a specialized field and a strong passion for education and research
- (2) Ability to put front-line clinical experience to use in education and research
- (3) Promote the benefits of research, such as from industry-academia collaborations, to society

5. Application procedures:

(1) Documents to be submitted

- ① Curriculum vitae (Form 1)
- ② Summary of educational, research, and other achievements (Form 2)
- ③ List of educational and research publications (Form 3)
- ④ Full copies of three major academic papers
- ⑤ A statement of purpose that briefly describes your educational and research activities, thesis guidance results to date, and aspirations for education and research after the adoption in English (non-designated format, about 400 words)
- ⑥ Opinions and initiatives regarding university reform, including educational reform (non-designated format, about 400 words)
- ⑦ Letter of recommendation (non-designated format) must be from department head or a person who can provide opinions on the field of specialty of the applicant. Also the letter must include the name and contact information of the person making the recommendation.

(2) Submission method

Submit application materials in person or by mail. (\*Please write “Teaching position application documents enclosed” in red ink on the envelope. If sending by mail, send by registered mail.)

6. Application period:

February 10, 2025 (Monday) to March 31, 2025 (Monday) (application materials must arrive by this date)

7. Candidate selection:

Candidate selection will be based on an examination of application documents and interviews including trial lecture.

Applicants will be notified of the selection results by August- 2025.

8. Employment starts:

October 1, 2025 or April 1, 2026
